

## Terms and Conditions

### Ticket Giveaway for Misbehavior – Ace Cinemas

1. This competition is open to those who comment on the competition post on the MWHCP Facebook post and are 16 years of age at date of entry.
2. By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. 3. Entries will be accepted starting on 7am Monday 16 November 2020 and ending Sunday midnight 22 November. All comment on post must be made prior to Sunday midnight 22 November to be eligible for entry.
4. The competition must be entered by commenting on the Facebook post prior closing time with a comment or tagging a friend you would like to take to the film. The entry must fulfill all competition requirements, as specified, to be eligible to win a prize.
